

Arizona Ink Studios Privacy Policy

What does this privacy policy cover?

This privacy policy describes the privacy practices of Arizona Ink Studios' websites, as well as our products, online services, and apps that include a link to this policy. This privacy policy also applies to Arizona Ink Studios' marketing and advertising practices. We will also provide additional privacy-related information for certain Arizona Ink Studios websites and applications.

What information does Arizona Ink Studios collect about me?

Arizona Ink Studios account registration

When you register to use an Arizona Ink Studios website or application, Arizona Ink Studios collects information that identifies you. This may include your name, email address, date of birth, or images. We may also sometimes collect other information that does not identify you. Some of this information is required and other information is optional.

Arizona Ink Studios websites and applications

We collect information about how you use our websites. We may collect information that your browser or device typically sends to our servers whenever you visit an Arizona Ink Studios website. For example, your browser or device may tell us your IP address (which may tell us generally where you are located) and the type of browser and device you used. When you visit an Arizona Ink Studios website, your browser may also tell us information such as the page that led you to our website and, if applicable, the search terms you typed into a search engine that led you to our website. Arizona Ink Studios may collect information about how you use our websites by using cookies and similar technologies, and our servers may collect similar information when you are logged in to the website. This information may be anonymous or it may be associated with you.

Arizona Ink Studios emails

Emails we send you may include a web beacon that tells Arizona Ink Studios whether you have received or opened the email, or clicked a link within the email.

Third party content from other companies

Arizona Ink Studios websites and applications may third party content that link to other companies' services (for example, a Facebook link). We may collect information about your use of these features. In addition, when you see or interact with these third party content, or view an Arizona Ink Studios web page containing them, some information from your browser may automatically be sent to the other company. Please read that company's privacy policy for more information.

How does Arizona Ink Studios use the information it collects about me?

Arizona Ink Studios uses the information we collect about you in a number of ways, such as:

- Providing you with the Arizona Ink Studios websites and applications for which you have registered, as well as any services, support, or information you have requested
- Better understanding how our websites and applications are being used so we can improve them and engage and retain users
- Diagnosing problems in our websites and applications
- Tailoring a website or application to your likely interests
- Sending you information about Arizona Ink Studios, new application releases, special offers, and similar information
- Reducing fraud, software piracy, and protecting our customers as well as Arizona Ink Studios

What are cookies and how does Arizona Ink Studios use them?

Like most websites and applications, we use cookies and similar technologies to make our websites and applications work, as well as to learn more about our users and their likely interests.

Does Arizona Ink Studios share my personal information?

All data collected stays within Arizona Ink Studios except in the following:

- You agreed to the sharing
- When we are required to provide information in response to a subpoena, court order, or other applicable law or legal process
- When we have a good faith belief that the disclosure is necessary to prevent or respond to fraud, defend our websites or applications against attacks, or protect the property and safety of Arizona Ink Studios, our customers and users, or the public

We may share or publish aggregate information that doesn't specifically identify you, such as statistical information about visitors to our websites or statistical information about how customers use our applications.

Is my personal information displayed anywhere on Arizona Ink Studios' websites or applications?

There are several places on Arizona Ink Studios' websites and applications that allow you to post comments, upload pictures, or submit content for others to see. There are some places where what you share can be seen by the general public or other members of the website or application. Please be careful when you share your personal information. Do not share anything you wouldn't want publicly known. If you choose to share personal information or a document, the terms of this privacy policy will not apply to any information shared. Please note that when you post messages on our websites and applications, your name may be included and displayed with your message.

To remove content you have shared on our websites and applications, please use the same website or application feature you used to share the content. If another user invites you to participate in shared viewing, editing, or commenting of content, you may be able to delete your contributions.

Is my personal information secure?

We understand that the security of your personal information is important. We provide reasonable administrative, technical, and physical security controls to protect your personal information. However, despite our efforts, no security controls are 100% effective and Arizona Ink Studios cannot ensure or warrant the security of your personal information.

Where does Arizona Ink Studios store my personal information?

Your personal information and data files are stored on Arizona Ink Studios' servers and the servers of companies we hire to provide services to us. Your personal information may be transferred across national borders because we have servers located worldwide and the companies we hire to help us run our business are located in different countries around the world.

How can I review or update my personal information or close my Arizona Ink Studios account?

Many of our websites and applications allow you to edit your personal information by accessing the "view profile," or similar feature of the website or application you are using.

If you want to request a deletion of your Arizona Ink Studios account, please email your request to Support@ArizonaInkStudios.com. Note that we need to retain certain records for legal or internal business reasons (such as fraud prevention). Some of your information may remain on backup systems, in compliance with applicable law.

We will retain your personal information for as long as necessary to provide you with the websites and applications you are eligible to use with your Arizona Ink Studios account, or as needed to comply with our legal obligations or enforce our agreements.

Will this privacy policy change?

Occasionally, we may change or update this privacy policy to allow Arizona Ink Studios to use or share your previously collected personal information in a materially different way. If we do, the links to the policy on our websites and online services (which are generally found in the footer of the website or online service) will indicate that the policy has been changed or updated. For new users, the change or update will become effective upon posting. For existing users, the change or update will become effective 30 days after posting. We encourage you to periodically review the Arizona Ink Studios Privacy Policy for the latest information on our privacy practices.
